

Programme Overview

The Foundation in Accountancy (FIA) is a qualification designed by ACCA specifically as the introductory qualification prior to training to become a Chartered Certified Accountant through the ACCA Professional Scheme.

The qualification proves to employers that the graduates have all the technical skills and knowledge needed to perform an accounts-support role and that one is capable of working at a technician level.

Graduates of FIA will proceed to the ACCA Qualification with the exemptions for the three Applied Knowledge papers.

Entry Requirements

SPM/O-level/equivalent 5 credits including in English and Mathematics.

Programme Structure

Candidates must pass all 7 papers (see the list below)

Standard course progression is 4-3 papers per semester over 2 semesters. Each semester is 6 months.

Programme Overview

Entry Requirements

- 2 Principal passes in STPM / A-Levels and 5 Credits in SPM / O-levels including English and Mathematics
- 5 Bs in UEC including English and Mathematics
- · Foundation or equivalent

Anyone can study for the ACCA Qualification

The ACCA programme is most suitable for people who aspire to become professionals in any field of business. University graduates of any discipline are eligible to join the programme. No previous knowledge of accounting or finance is required. All that is needed is the drive and passion to pursue it!





Programme Structure

Candidates must pass all 13 papers (see the list below) to earn the ACCA qualification. Standard course progression is 3-3-3-2-2 papers per semester over 5 semesters. In the case of FIA students progressing in to the ACCA Qualification, their standard course progression would be 3-3-2-2 papers per semester over 4 semesters. Each semester is 6 months duration; 5 semesters would be 2.5 years while 4 semesters would be 2 years of study duration.

Although ACCA holds quarterly exams i.e. in the months of March, June, September and December, Imperium International College preparesi ts students toward the half-yearly exams in the months of June and December. The six-month duration allows many professional skills enhancement activities, especially IT related workshops, to be organised to nurture the students and make them make them competitive in their career.




